EXECUTIVE PROGRAM FACULTY BIOS

John H. Daniels, FACHE, FHIMSS

John H. Daniels, FACHE, FHIMSS, is vice president and chief information officer of Evolvent Technologies Inc. He is a strategic and customer-focused executive with 23 years of professional experience. He is a retired officer of the United States Air Force, having served as chief information officer (CIO) of the U.S. Air Force Academy Hospital in Colorado Springs, Colo. He has held CIO positions for other military medical organizations including the U.S. Department of Defense's former Health Services Region 5 and has worked in private and military clinical settings as a mental health associate and psychometrician. Daniels also was senior fellow and vice president of IT operations at the Harris County Hospital District in Houston. Daniels is a recognized industry thought leader currently serving on the HIMSS board of directors.

Thomas C. Dolan, PhD, FACHE, CAE

Thomas C. Dolan, PhD, FACHE, CAE, is president and chief executive officer of the American College of Healthcare Executives. Before his appointment as president and CEO, Dr. Dolan served as ACHE's executive vice president. Prior to joining ACHE, he held a variety of teaching, research and administrative positions at St. Louis University, the University of Missouri-Columbia, the University of Washington and the University of Iowa. Alan S. Prior to working at Tulane University Hospital & Clinics, Marty served as director of Employee Assistance Program/Worksite Wellness at Xavier University of Louisiana.

George Mikitarian Jr., PhD, FACHE

George Mikitarian, FACHE, is president and chief executive officer of Parrish Medical Center (PMC). He began his tenure with PMC in 1996 as chief operating officer. Under his leadership, PMC was one of the nation's first replacement facilities to be constructed using evidenced-based healing design. PMC was voted America's No. 1 Healing Hospital by the Baptist Healing Trust for cultivating a culture of loving service for three consecutive years. Other accomplishments under Mikitarian's leadership include:

- Opening Florida's first Silver LEED certified 'green' outpatient center in May 2007
- Earning more Joint Commission disease-specific Gold Seals than all but one other in the state of Florida, including primary stroke (No. 1 in Central Florida), diabetes, congestive heart failure and wound care, with three more pending acute coronary syndrome (to be No.1 in the state), breast cancer (to be No. 1 in the state) and palliative care (to be No. 1 in the state)

David B. Nash, MD, FACPE

David B. Nash, MD, FACPE, is the newly appointed Founding Dean of the Jefferson School of Health Policy and Population Health on the campus of Thomas Jefferson University in Philadelphia. Dr. Nash also is the Dr. Raymond C. and Doris N. Grandon Professor of Health Policy and this endowed professorship is one of a handful of such chairs in the nation. The appointment as the Founding Dean culminates a nearly 20-year tenure at Jefferson. Dr. Nash is a board certified internist and founded the original Office of Health Policy in 1990. Thirteen years later, the Office of Health Policy evolved into one of the first departments of health policy in an American medical college. In 2008, the board of Jefferson University approved the creation of the new school. The Jefferson School of Health Policy and Population Health represents the first time a health-sciences university has placed four masters programs under one roof, namely a Masters in public Health, Health Policy, Healthcare Quality and Safety and Chronic Care Management. The goal of this innovative school is to produce a new kind of healthcare leader for the future.

Anthony Nieves

Anthony Nieves is the senior vice president of Supply Management for Hilton Hotels Corporation. Nieves oversees end-to-end supply management services and solutions for all properties within the Hilton family of brands. A recognized leader within the supply management and hospitality industries, Mr. Nieves serves as the chair of the Non-Manufacturing Business Survey Committee for the Institute for Supply Management (ISM). He is the past chair of the board of directors for ISM and is the chair emeritus for the ISM—Hospitality Supply Management Forum (formerly an executive study group of the National Restaurant Association). Nieves is the chairman of The Conference Board's Purchasing and Supply Leadership Council. Additionally, he is a board trustee for the Center for Advanced Purchasing Studies, a supply management research organization; certified purchasing manager and accredited purchasing practitioner through ISM; and a certified foodservice purchasing manager through the National Restaurant Association.

Kevin E. O'Connor, CSP

Kevin E. O'Connor, CSP is the principal of Kevin O'Connor & Associates Ltd. and a faculty member at Loyola University Chicago as well as Columbia College in Chicago. He specializes in working with business professionals who have been promoted to leadership and sales positions where they now lead and influence their business peers. In the past 14 years, Mr. Stokes has served as executive vice president and chief operation officer for three different healthcare systems in Louisiana, Arkansas and Alabama. He currently serves as a preceptor on the faculty at the University of Alabama in Birmingham.
